**Subject:- Appointment to the post of Registrar in the National Highways Tribunals under the control of National Highways (Land & Traffic) Act, 2002 on deputation basis.**

Sir,  
I am directed to say that it is proposed to fill up the posts of Registrar in the National Highways Tribunals set up under the National Highways (Land and Traffic) Act, 2002 located at Mumbai, Lucknow, Chandigarh, Kolkata, Jabalpur, Bangaluru, Chennai and Guwahati. The posts of Registrar in the Pay Band-3 (Rs. 15600-39100) plus Grade Pay of Rs. 7600/- are proposed to be filled on deputation basis by appointment of officers working in various Ministries/Departments of the Central Government and the State Governments/UTs, initially for a period of one year, which is further extendable by two years.

Officers of Central Government/State Govts/UTs holding analogous posts on regular basis or with five years regular service in the posts in the scale of pay of Rs. 10,000-15,200/- (pre-revised) or Pay Band-3 (Rs. 15600-39100) plus Grade Pay of Rs. 6600/- and having experience of working in Tribunals, judicial process, establishment and administrative matters will be considered as eligible for appointment to these posts. The maximum age limit shall be 56 years as on the closing date for receipt of applications.

The applications of eligible and willing officers along with their up-to-date ACR/APAR dossiers for the last 5 years, vigilance clearance, intergrity certificate and details of Major/Minor penalties imposed during last five years may be sent in the enclosed proforma so as to reach the undersigned with in 45 days from the date of publication of this circular in the Employment News.
