**Sub: Phase V course of MCT Programme for IAS officers – regarding**

Madam/ Sir,

Please refer to Joint Secretary, Training Division's demi-official letter no T-17012/10/2015-Academy Desk of June 16, 2015 regarding nomination of eligible officers for participation in the Phase V of the Mid-Career Training (MCT) Programme for IAS Officers that is scheduled to be held from October 11 to November 6, 2015. The training programme is mandatory for officers who have completed 28 years of service, although officers who are entering into 28<sup>th</sup> year of service would also be considered, subject to availability of seats.

2. The details of the programme and the procedure for nomination are given below:

2.1 The 4-week course will begin with a curtain-raiser function to be held in New Delhi on October 11, 2015 to be followed thereafter by one week programme at Delhi. Officers will leave for a one-week Foreign Study Tour on October 17/18 for studying good practices abroad in groups of 25-30 each. Option for selecting the aboard training will be sought later upon receipt of confirmation of their participation from the State Government/ Government of India. The officers will return to India on October 25 and be expected to report for the domestic component of training at the Academy from October 26 to November 6.

2.2 The main objective of the Phase V training to build "next level competency" and prepare IAS officers for becoming effective Additional Secretaries and Secretaries to the Government of India and equivalent positions in the State Government. The officers with 28 years of service would hold senior positions in the Central or State Governments during next few years and would deal with strategic issues pertaining to governance. Therefore, our endeavor is to expose them to best practices in policy formulation based on in-country and international experience.

2.3 Officers of following batches would be eligible to attend the programme this year.

- (i) Officers of 1988 batch (1<sup>st</sup> chance)
- (ii) Officers of 1986 and 1987 batch (2<sup>nd</sup> chance)
- (iii) Officers of 1985 batch (3<sup>rd</sup> chance)
- (iv) Officers of 1983 & 1984 batch (on case to case basis)

2.4 The mandatory nature of the programme is sought to be underscored by the fact that no increment is awarded after 28<sup>th</sup> year of service in the event of non-participation. In the past, Government of India has allowed postponement of participation only in rare and extraordinary circumstances. Moreover, any approval for postponement of participation does not entitle the officers to obtain the respective promotion/ grade/ increment in relaxation of the Rules. In view of this, it is requested that eligible officers are advised to participate in the training programme at the earliest opportunity.

2.5 Officers are required to register for attending the programme on-line by accessing a specific link on the home page of the Academy website (<http://www.lbsnaa.gov.in>). The last date for online registration is **August 15, 2015**. Academy has implemented a Campus Management Software called SARGAM (<https://lbsnaa.sargam.gov.in>). This would be single-point contact for the participants to receive and upload all information relevant to the Phase V programme. Upon online registration, Academy will send them a username and password through which they will gain access to SARGAM.

3. You are, therefore, requested to advise the officers of the 1988 batch as well as officers of 1987, 1986 and 1985 batches, who could not attend this training programme so far, to register themselves online. It is also requested that Government clearance for the registered officers may be sent at the earliest and all nominated officers should be released timely for attending the programme. The Academy would confirm participation of the officer only upon receipt of formal clearance of the State Government/ Nodal Ministry in Government of India.
