The qualification (s) regarding experience is/are relaxable at the discretion of the U.P.S.C, for reasons to be recorded in writing, in case of candidates belonging to the scheduled Caste or Schedule Tribes, if at any stage of selection, the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill-up the vacancies reserved for them.

DESIRABLE:-

Ph. D in Veterinary Science/ Animal Husbandry of a recognized University or equivalent. Period of deputation (ISTC) in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Govt. shall ordinarily not exceed 4 years. The maximum age limit for appointment by deputation (ISTC) shall be not exceeding 56 years as on the option to draw his Grade pay+ Deputation (duty) allowance in terms of Govt. of India, Ministry of Finance (Department of Expenditure) Office Memorandum No. 10(24)/E-III/60 dated 04-05-1964. Only officers under Central/State Govts./Union Territories will be eligible for absorption.

1. DUTIES OF DIRECTOR (ANIMAL HUSBANDRY)

The Director will be Head of Unit of Animal Husbandry and to directly supervise the activities of the Veterinary Hospital/Dispensaries and officers working in the Animal Husbandry unit of Development Department of GNCT of Delhi.

The deputation of the officer selected will be regulated in accordance with FR 9 (25) and G.I., Deptt. Of Personal & b Trg., O.M. No. 2/29/91-Estt.(Pay II), dated the 5th January, 1994.

The applications (in duplicate) in the annexed proforma along with the complete and upto date ACRs dossiers (In case of photocopies of ACRs, the same should be attested by an officer, not below the rank of Deputy Secretary, Govt. of India) and status of major/ Minor penalty, if any levied, on the officers so sponsored, should reach this department within 60 days of publication of vacancy. Application of only such officers who have at least three years service before their superannuation and who can be spared in the event of selection, will be considered . While forwarding application, it may please be certified that there is no vigilance case pending/ contemplated against the officers concerned.
