APPOINTMENT OF CHAIRMAN AND MANAGING DIRECTOR (CMD), THE SHIPPING CORPORATION OF INDIA LIMITED (SCI)

The Shipping Corporation of India Limited (SCI) was incorporated under Indian Companies Act, 1956 by amalgamation of Eastern Shipping Corporation and Western Shipping Corporation with the objective to serve India's overseas and coastal sea borne trade as its primary flag carrier and be an important player in the field of global maritime transportation as also in diverse fields like offshore and other marine transport infrastructure. SCI is a schedule – 'A' Navratna CPSE in the transportation services sector under the administrative control of Ministry of Shipping. The authorized and paid up capital of the company was Rs. 1000 Crores and Rs. 465.80 Crores respectively as on March 31, 2015. The shareholding of the Government of India in the company is 63.75%. Its Registered and Corporate offices are at Mumbai, Maharashtra.

Applications are invited for the post of Chairman & Managing Director, SCI to be appointed on full time/immediate absorption basis as per the details mentioned below:

1. Job Description and Responsibilities.

Chairman and Managing Director is the Chief Executive of the Company and is accountable to the Board of Directors and Government of India. He/She is responsible for the efficient functioning of the Corporation and for achieving its corporate objectives and performance parameters.

2. Pay Scale of the Post.

Rs. 80,000-1,25,000 + PRP + other benefits as admissible.

3. Eligibility and Qualifications / experience.

i. **AGE** should be minimum of 45 years and maximum 57 years as on April 1, 2016.

ii. Qualification and Experience.

The applicant should be a graduate with good academic record from a recognised University/Institution. He should possess adequate experience at a senior level of management in large organization of repute. Persons with maritime/MBA qualifications and having experience in Management and familiarity with Finance/Marketing / Production will have added advantage. Knowledge and experience of Shipping/Transport Industry/logistics is desirable.

(a) For Officers of CPSEs.

Candidates should, on the date of advertisement, be working in the following or a higher pay scale of:

Executive Director or equivalent of a Schedule "A" CPSE.

(b) For officers of Central govt. / Armed Forces of the Union / All India Services
