The National Institute of Solar Energy (NISE) is an Autonomous Institute of Ministry of New and Renewable Energy, Government of India to function as an Apex National Centre for research and technology development in the areas of Solar Energy Technologies. NISE is located on a 200 acre campus at the Gurgaon- Faridabad Road, Gwalpahari, and Gurgaon. The R & D activities of NISE are carried out in coordination with other research organizations and industry. NISE has decided to fill up two posts of Deputy Director General/Scientist 'F' in National Institute of Solar Energy, Gurgaon on deputation basis (including short term contract) from amongst the officers holding analogous posts under Central Government or State Governments or Universities or recognized research institutions or Semi Government or Statutory or Autonomous Organizations.

2. Officers holding analogous posts on regular basis, having requisite qualifications and experience as mentioned in the Annexure-I and having completed their period of probation in the present organization can apply for appointment on deputation to National Institute of Solar Energy indicating the name of the post through proper channel. All the officers who are presently working on deputation (ad-hoc) basis may also apply. The details of the post and scale of pay of post, qualification and experience required for the post is at Annexure-I. 3. The officers selected for appointment on deputation to NISE may either retain their grade pay in the scale applicable to them plus deputation allowance and other allowances as admissible in the parent cadre, or draw their pay in the post of Deputy Director General. The period of deputation, including period of deputation in another ex-cadre post held immediately preceding this appointment in same or some other Organization or Department of the Central Government shall not ordinarily exceed three years, which may be extended further on year to year basis, subject to a maximum of five years with the approval of the

competent authority. The maximum age limit for appointment by deputation shall not exceed 56 years or as prescribed by Government from time to time, as on the closing date of receipt of application. The terms of deputation will be governed by standard terms of deputation as prescribed by the Government of India from time to time.

4. Applications in the prescribed proforma (Annexure II) should be forwarded to Director General, National Institute of Solar Energy, Gwal Pahari, Gurgaon-Faridabad Road, Gurgaon, 122003 Haryana so as to reach him within 6 (six) weeks from the date of publication of the advertisement in the Employment News. For candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangi Sub-division of Chamba District of Himachal Pradesh, the Union Territory of Andaman & Nicobar Islands and the Union Territory of Lakshadweep Island, the applications must reach within **8 weeks** from the date of advertisement in the Employment News. All applications should reach the Institute through proper channel within the prescribed time-limit. Advance copies of the applications will not be entertained.

While forwarding the application, the following documents may also please be sent to this Institute along with the application.

- (i) A Certificate to the effect that Central/State Government or the Parent Department/Organization has "NO OBJECTION" to the appointment of the officer concerned in NISE on deputation.
- (ii) Attested copies of the ACRs/APARs of the applicant for the last five years.
- (iii) A Certificate about the integrity of the officer recommended for appointment on deputation in NISE.
- (iv) Vigilance Clearance in respect of the applicant duly signed by an officer of the appropriate status.
- (v) Certificate of major/minor penalty imposed if any on the officer during the last ten years/service period whichever is less.

Incomplete application(s) received without above-mentioned documents will be summarily rejected. In case application along with the requisite documents is not received within the stipulated time, it would be presumed that the parent organization is not in favour of appointment of the application on deputation. The Institute will not be responsible for collection of the above mentioned documents.
